RESOLUTION AMENDING PROPERTY MAINTENANCE CODE

WHEREAS, the Board is authorized under Revised Code Section 505.73 to adopt, administer and enforce within the township a Property Maintenance Code, pertaining to the repair and continued maintenance of structures and the premises of those structures; and

WHEREAS, the Board adopted a Property Maintenance Code on September 25, 2006, which became effective January 1, 2007; and

WHEREAS, the Board desires to amend the Property Maintenance Code and is authorized to do so under Revised Code Section 505.73.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. Section 103.1 of the Green Township Property Maintenance Code is amended to read as follows:

103.1 General. The Green Township Police Department and the Green Township Department of Public Services shall be responsible for the enforcement and application of this code. The Green Township Director of Public Services and the Green Township Police Officer Troy Biggs shall each be known as the code official.

2. The effective date of the amendment to the Property Maintenance Code shall be January 18, 2016.

3. The Township Fiscal Officer shall post a notice that clearly identifies the Amendment to the Property Maintenance Code, states the amendment's purpose, and states that a complete copy of the code is on file for inspection by the public with the Fiscal Officer and in the County Law Library and that the Fiscal Officer has copies available for distribution to the public at cost.

4. The Township Fiscal Officer shall post the notice in five conspicuous places in Green Township for thirty days before the code becomes effective and shall publish the notice in a newspaper of general circulation in Green Township for three consecutive weeks. The notice shall include a brief summary of the amendment to the Green Township Property Maintenance Code.
