RESOLUTION #18-0226-†

RESOLUTION PROHIBITING THE ESTABLISHMENT OF ANY ENTERPRISE THAT INCLUDES RETAIL DISPENSARIES, CULTIVATORS, OR PROCESSORS OF MEDICAL MARIJUANA WITHIN GREEN TOWNSHIP, OHIO

WHEREAS, Ohio Revised Code Chapter 3796 authorized the licensure of medical marijuana cultivators and processors, as well as retail dispensaries of medical marijuana in the State of Ohio; and

WHEREAS, for the purpose of this Resolution, reference to "cultivators", "processors", and "retail dispensaries" are given the same meanings as those found in Chapter 3796 of the Ohio Revised Code; and

WHEREAS, Ohio Revised Code Section 3796.29 authorizes a township board of trustees to prohibit cultivators, processors, or retail dispensaries licensed under Chapter 3796 of the Ohio Revised Code in Green Township; and

WHEREAS, the Green Township Board of Trustees believes it would be in the best interest of the citizens of Green Township that it prohibit entirely the cultivation, processing and/or retail dispensing of medical marijuana.

NOW, THEREFORE IT RESOLVED, by the Trustees of Green Township, Hamilton County, Ohio, as follows:

SECTION 1-A:

The Board of Trustees hereby prohibits the establishment of any enterprise that would include the cultivation, processing, and/or retail dispensing of medical marijuana within the limits of Green Township.

SECTION 2:

This resolution shall take effect February 27, 2018, following the filing of this resolution with the Green Township Fiscal Officer.

SECTION 3:

It is hereby determined that all formal actions of the Board of Trustees relating to the adoption of this Resolution were taken in an open meeting of the Board of Township Trustees and that all deliberations of such Board of Trustees were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


